

Minutes of the meeting of the Fire and Police Commission held Thursday, October 28, 2021 at 8:30 a.m. in the City Hall Council Chambers.

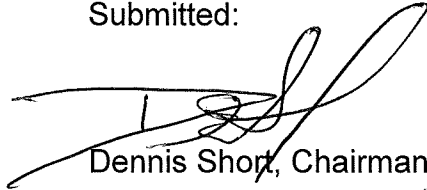

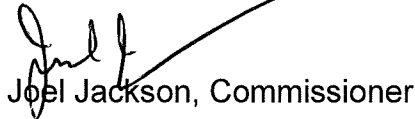
