Old Business:

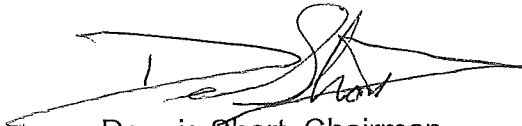
FD Promotional Testing Timeline

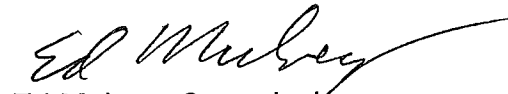
